We refer to your letter dated November 25, 2020 seeking certain clarifications on Shareholding Pattern filed by the Company for the quarter ended September 30, 2020. Please find below our point-wise response:

**Query 1:** *There is change in PAN of shareholder GAUTAM PURI in promoter category.*

**Reply:** There is no change in PAN of Mr. Gautam Puri. Mr. Gautam Puri holds shares in his own name, as well as in the name of his HUF. PAN of both are given below:

1. Mr. Gautam Puri in the Promoter Category PAN - AAHPP5688E; and
2. Gautam Puri HUF as Member of Promoter Group PAN - AACHG4390R.

Kindly note that till June 30, 2020 the shares held by Gautam Puri HUF were being shown separately (separate from those held by him in his individual name), but name appearing was Gautam Puri, instead of Gautam Puri HUF.

In the Shareholding Pattern submitted by the Company for quarter ended September 30, 2020, this discrepancy has been rectified and the correct name i.e. Gautam Puri HUF has been mentioned against the said shares.
