We refer to your letter dated September 11, 2020 seeking certain clarifications on Shareholding Pattern filed by the Company for the quarter ended June 30, 2020. Please find below our response:

Query: *There is a change in number of Promoters. Following are the details*

Reply: The above is an addition in the promoter group. Mr. Gautam Puri holds shares in his own name, as well as in the name of his HUF. PAN of both are given below:

1. Mr. Gautam Puri in the Promoter Category PAN - AAHPP5688E; and
2. Gautam Puri HUF as Member of Promoter Group PAN - AACHG4390R.

As on March 31, 2020, Gautam Puri HUF did not hold any share in the Company, hence its name was not shown in shareholding pattern filed for the quarter ended March 31, 2020. Kindly note that till June 30, 2020 the shares held by Gautam Puri HUF were being shown separately (separate from those held by him in his individual name), but name appearing was Gautam Puri, instead of Gautam Puri HUF.

In the Shareholding Pattern submitted by the Company for quarter ended September 30, 2020, this discrepancy has been rectified and the correct name i.e. Gautam Puri HUF has been mentioned against the said shares.
